It's just that, let's say the budget itself, the budget summary page, and then there's five pages behind that of all the appropriations.

I have no intention that we would go through the appropriations.

It's there just so people, when they take it home, can make a look at it if they so choose.

There would probably be that budget history shows the history of the budget, particularly excess capacity, which Bart, that's what I think we could spend some time on what excess capacity is and at the same time throw in why the overrides are two different numbers and that they're only the tax impact.

If you look on that budget summary page, the number that's in there is the lower number.

195,000.

And then if you scroll down, it shows the impact to the average single family tax bill.

And then on the excess capacity line, it's no longer red, it's black, and it's excess capacity.

So that would be explained.

And I didn't put in another column showing the 290 simply because it got too wide.

So I would just say to this, if the 190 is voted in, the net effect to the taxpayer would still be the same.

And the only thing here is excess capacity would be increased by 95 grand or whatever the number turns out to be.

To that I wonder about a cover sheet that really draws out, you.

Know, there will be a vote this time, the ballot question is below, this is what, you know, this is the one is not very much excess capacity, the second one is excess capacity, something which I will draft and I'll send to you and you can decide what to do with it.

But I want to go back to that, I can't remember what it's called, the budget spreadsheet that's in the handout that starts on page 3-4, and it's your usual.

So you just were saying that you added a column where the override is highlighted at 195, and it tallies up and gives the tax rate in the average single tax single-family tax bill so there are two comments I would make on that one is that one of the reasons we chose 195 is because the new growth line is an estimate and I would really call that out in some way because I think it's important that I don't think any of us think it

will go dramatically down.

But it is an estimate.

And we inflated the override number because there is a chance that it goes to zero.

And this would allow us to be covered.

And it would be nice if it were explicit.

And the second is, I think it actually is, I mean, maybe people won't ever look at this sheet.

They don't really understand what it means.

But personally, I think it's more important that they see that the two votes have the same impact to their tax rate than it is to see what fiscal 2023 looked like.

And that it will not be known until the assessor's measure enlisted, put it together, sent it to DOR.

So when we talk about going over the very first page, that can be explained that new growth is not known yet.

And one of the reasons why the 95 was picked was to cover in case new growth comes in less than the current estimate.

I would just italicize it on the spreadsheet, just that 48,682.
