#### Conversation about:

New ADU law goes into affect in February

ADUs may no longer go before the planning board (possibly)?

• Question of current non-compliant ADUs - how to bring them into compliance from the building inspection perspective.

• Existing ADU's still have to be in compliance with the code: would all have to be on a case by case basis.

• Clarification of 900 sq feet for the town vs. the state

• New building Inspector = 900 square feet is foundation/ conditioned space.

• State law will super cede town law

- Question of short term rentals: discussion of them working against housing goals
  - (1-3 year) Inspection of Short Term Rentals as part of the State building code changes
  - Idea of a special permit for Air BnBs for ADUs or primary structure:

• Short Term Rental as a special permit vs. license.

- What is the definition of a "short term rental" for Worthington.
- What is the definition of "owner occupied" for Worthington.
- No owner occupation is necessary anymore via state law.
- Initiate conversation with the Select Board about short term rentals.

• Zoning special permit vs. license.

- Question of who is tracking ADUs after the permit is opened.
  - If the Select Board approved permitting software than it would make the permit process much more accessible. Around \$6,000/ year.

#### Plan of Conversation with Town Council and the Select Board

Nestor reports back from the Select Board:

Phase 3 charging stations for charging electric vehicles

- 2 proposed locations are at the town hall and at the school.
- Eversource will be putting a charging station in town.

- denser housing

As the Planning Board we are wondering if it makes sense to change the frontage for just the "Town center" or create mixed use availability in the town center.
