We're gonna talk about the highway department So if we get a quick update and then I think we want to talk about, um, Travis's pay and we have a driveway application.

So we'll get to that last.

Before you start, I think you guys did an awesome job.

And I mean, and I'm sure you're encountering this because I was driving down Patterson road and I, and I was just, I was in the woods as I always do and one of our neighbors got plowed out into the middle of Patterson Road and I'm sure you're dealing with that with everywhere and the drifting and I think you guys did a great job for a small for just period I mean that was a long storm yes so that's that makes it hard because it's if it dumps all at once and you're done you're done but when it's like that Here you come again.

We have probably a good handful of households in town where they push all the snow into the road or snow blow it all into the road, just into the road, and I had just recently talked with be about it because it is illegal and if an accident was to happen ultimately they're gonna come to me first and say why is this in the road and then last thing you want is it to go back on the homeowner because they're the one pushing into the road which is illegal so it's really not gonna happen.

So are we talking about the difference between pushing it into the road versus pushing it across the road?

Across the road is still legal.

We have about a handful of residents that push it into the road or snowball it into the road and assume you're just going to clean up.

Eventually when I'll drive by checking the roads the next morning and see there are six inches of road across this one stretch of the road and both lanes like we can't have this.

Yeah, I followed off the road.

So a do we just try to put something general out to the town which is probably the wisest thing or do we try And I maybe as a first step and then as a second step Start addressing people Having scoby did it sounds like a great idea.

He said we can talk to them as I call him about it Okay, frankly, it's just been very busy.

Well, yeah, so so why I will go ahead and put something out Is there anything else to let tell people I pull the same thing in the same area Did you did you talk about the sand thing and putting out a notice that two buckets per store per household?

I had talked to Amy and I believe Deb about People complaining about not having enough sand out in the sand bin Yes, and the sand bin is it might be worth just a notice of just saying that the sand bin is filled when We're in working during the week, right if it runs out on saturday.

We're not on call to just fill the sand bin Yeah, right and And should we ask people to try to limit themselves the two at a time where I was talking to them about is a lot of

other towns around us and it's is that it's not on the town's budget, I believe, to sand everybody's driveways.

Well, that's not even legal.

If people were going to be taking that much sand to sand their entire driveway, that kind of defeats the purpose of what it's there for.

So if we're going to make signs up and put two five-gallon panels per household per storm.

Oh, yeah They back up pick up trucks and stuff over there and they really shouldn't do that.

No I'm sorry.

You need that much.

You really it is expensive to have your driveway Sanded, you know, but sure part of it, but yes Okay, so I will include that so we'll talk about saying talk about calling across the road anything else and into the road and into One of my neighbors used to do that, but it stopped pretty quickly.

So I'd like to go take a picture.

Plowing across the road at least 50% of the town does seriously You can drive by Most of driveways in town and there's either a trail going across the road or you'll see it directly across from the drive Or they push it up right that's where I see but Or that's still technically technically legal because it's going across the town road But I'm not looking to argue that because you got to do something with the snow and Half the town does it and has done it for forever it's just the leaving the snow in the road and creating an actual hazard well it's one thing if it's a homeowner too and there's no way to know which one it is but it's another thing if it's somebody's contractor that's doing it they should know better.

We're not planning it next year, I believe is the plan for it.

Does it take six months to get a truck?

It takes longer than that.

So the only would be to get it before winter, yeah.

So we ordered it so we waited till spring of next year we could get a truck in time for that coming.

Because from my understanding of the way things were done is all the trucks were on a 10 year basis for the most part to get replaced.

And next year, one of them is definitely up.

So we want to talk about Travis?

Yeah, you guys wrote a note that I think maybe you want to kind of give the highlights to the select board, the entire select board.

Travis was picked.

08:06 - 08:08

Worthington Town Hall

Do you want me to do it or do you?

Worthington Town Hall

Oh, you can do it.

Worthington Town Hall

Or you can interpret what So.

Worthington Town Hall

We hired Travis, who came with all the qualifications, but his hoister license, and we started him at \$30.40 an hour, contingent upon him getting his hoister's license.

He is now performing the same jobs that the two other highway employees are that are making 3424.

08:44 - 09:05

Worthington Town Hall

I know that some of this has to do with time and job and everything, but I think it would be the recommendation here is to increase his pay to 3357 to kind of bring everybody up to speed given that Travis has equivalent experience, qualification.

And licenses.

09:06 - 09:27

Worthington Town Hall

And so the proposal is to raise that to \$33.57 to address the internal pay inequality and reflective qualifications and experience and support employee morale.

I think there might be some comparing of what everybody's doing and how well they're doing it and what their compensation is.

So I think that, so I think it would be good for us to have a discussion about that and then maybe I could make a motion, but I'm not ready to make a motion.

So his current pay is \$30.40?

09:52 - 09:52

Worthington Town Hall

Correct.

09:52 - 10:03

Worthington Town Hall

So the history of why we requested \$33.57 is because that is what the last two hires previous to Travis were starting pay at.

Worthington Town Hall

We didn't think that he should be equal to what the current pay is, due to the fact that that was based on a Collins study raise.

10:14 - 10:21

Worthington Town Hall

So we just thought that if you could keep some consistency on that respect.

We also offered that moving forward, any time we need to hire for a highway department personnel, that we have a very strict higher start pay that does not necessarily need to reflect what's happening at this moment.

It could be the 30-40, or it could be a step lower.

But just because I think there was an understanding that there would be some sort of raise with the attaining of the hoistage license that we felt that maybe the starting pay that the last two employees got would be a fair, happy medium.

Thank you.

So there is a starting rate.

11:07 - 11:09

Worthington Town Hall

That's what the current schedule is all about.

11:09 - 11:16

Worthington Town Hall

So it is a grade C job and grade C starts at a low number and goes to a high number.

Worthington Town Hall

And the whole idea is that we hire somebody based on their experience basically and what the going rates are at that time, which is what we tried to do, I think.

You're asking for a one, two, three, four, five step raise.

We've never done that as long as I've been on the software.

It's just pretty unusual.

The current employee that's been for a longer time got more than that over a year ago.

And the people that were hired before Travis, I don't know if they had less or equal to experience.

And an argument I have for Travis is, I know he just obtained the license, but as since now he has a license, he's legally able to operate our equipment here.

And his experience from operating equipment before here really shows now that he has his license and able to operate.

And I feel he's very much worth it.

His skill level is there.

Compared to what we have.

So what happened previously was A, we hired Seth who, you know, for better for worse, came with a lot of experience and didn't work out very well in the end, but he presented well and that's what we negotiated.

And at the time, I don't recall who made the motion and the whole discussion, but we did agree to raise Ted's pay to meet his.

It was Cork.

You're right, Cork said that if you're going to hire this guy this much, I don't think it's fair that my guy who's been working here is only being paid whatever, you know, he was the one who got the big job, is only being paid that.

But in retrospect, it was a mistake.

I think we are, most of us I know have to agree on that.

It's not unusual for people to have different opinions and a job based on.

I agree with that.

I think that when you get hired it has Quite a bit to do with it, but I do think that I Mean like to have a discussion so I can make a make a motion for discussion about some kind of a pay raise for Travis because I do really believe that it is It is affecting Morale and just I mean.

You know for better for worse our pay reflex in some way our feeling of self-worth and you do compare yourself to others.

And I can say that this is already budgeted.

In fact, you're saving money, because when we did the budget for fiscal year 26, which is what we're currently in, we had two people at the higher rate, and Devin.

And now we have a new Devin who is making a less amount because he's of experience.

Sure.

And now we have the same amount of employees.

So technically, your budget isn't perfect.

Well, as far as the overall budget.

14:21 - 14:22

Worthington Town Hall

It's not better.

Worthington Town Hall

So yeah, definitely, as far as what we're paying in salaries, it's less than your budget, obviously.

We have one less person.

14:29 - 14:31

Worthington Town Hall

So that's a big jump in the number.

14:31 - 14:33

Worthington Town Hall

But by all means, make a motion.

Are you prepared to make a motion?

Worthington Town Hall

No, I'm getting this.

Worthington Town Hall

I mean ideally we make a motion that we raise Travis's hourly pay to 3357 prior to the Cola and Collins study adjustment and what is what's Ted.

So that would bring him up to, do we call it a class, a C-17, no a C-18, sorry.

Yes, and Ted is at 19.

I'll second the motion.

So I would like to, this is my dealing with.

We made a mistake when we hired Seth and bumped Ted up that high.

That was an error and we've sort of been trying to, because of all the budget constraints, we've been trying to get things back into line.

I think that Travis has been doing a really good job.

Worthington Town Hall

I personally watched him do part of his on my property and I think that I understand I heard what you're saying what you're saying and I agree that if there's a morale I think there is a morale thing going on if there's there's some stuff going on that I'm not really happy about I'm sure you aren't either but it's stuff that we will have to figure out and work out but I think that I kind of agree with this increase I feel that we should do it.

I would like to keep Travis.

I would like to not lose him and it is possible that we will then be looking for that somebody else will go and we will be looking for somebody to replace that person and that replacement would not come in at that existing wage.

So I sort of feel like the trouble that we have is trying to get things back into balance without being really harsh on any one person and I don't want to be harsh on um Travis at all.

So um much as I wish we didn't have to I think we should.

So I'm not opposed to considering some sort of increase um I think a five-step increase is just not not right.

That's not fair to other employees in town.

We've never done that like this at least the 10 years.

Since we created the college schedule, 10 years I've been on, so it's just a huge jump.

I mean it's not a huge jump dollarized, but it's a huge jump as far as the way we pay people.

The one time that there was an increase to a person's salary was mine, and I had a good time mainly when we had a discuss there.

Remember, I was asking for \$12 ,000 more a year.

Well, we I think we increased your hours at the same time I think you went from 34 to 40 or something Yeah, which is all great.

Yeah, I always work.

Worthington Town Hall

And I wouldn't suggest we go to town meeting no, no.

Yeah, I was gonna say I would just that we never ever yeah that was horrifying Yeah, everybody was really nice, but the people who weren't were just nasty Yeah, really?

Yeah, and nobody should have this and really it was a fine.

It gets added in automatically.

So budget season is when we figure it out.

And we haven't actually done a COLA, figured out what the COLA is.

You did it last year, right?

Right.

We have it.

Yeah, but it's Right, it's around two and a half still To bait to five something So that's yeah So if we gave him some kind of a step increase, whatever it is He would still get his step increase in July.

Well, that's well, that's part of the question Yeah, well, yeah, that's what you should figure out if we're going to give him an increase now or are we gonna?

To give him another increase in the spring.

And in truth, he's been getting a C-grade pay since September anyway, even though it's less than he wants now.

And he has been.

Since he didn't have a license.

Right.

And I did look back at the minutes and it was clearly discussed that assuming he got his license, Get a step in and call it like everybody else's friends, and there was no discussion of any change in the mid-year Well, I think that's why Christine said if we hire somebody else looks make sure we have this crystal clear Because I think the issue is that there everybody's coming a bit of a different story.

Well, I think well I what I think she needs a little bit more is I think that Neither of you is as familiar with these steps and the grades as obviously we are We work with it and I think that's what it is to the whole Like the whole point of the schedule is to

make the pay system in this town fair and and it was based the the initial Numbers were based on a comparison of other towns in the area and what everybody was getting paid for very it for all jobs all salary didn't and hourly jobs and then to establish a system that would give people a Guaranteed raise in essence every year and.

And the trick is always when you hire somebody's so what is the building rate and you know, what can we get you for and we're.

And constantly poking the bear.

Getting him mad saying, I was promised a raise.

I need a raise.

He wasn't.

Worthington Town Hall

I think that's kind of, I can understand his not remembering that because he's getting, he's getting poked all the time, you know, and that's through the problem here.

We're trying to solve, you know, a problem with the wrong tool to a certain extent here.

If the problem is somebody causing trouble.

Now, if Travis is underpaid and deserves some sort of raise for getting the license and everything, I'm willing to listen to that.

That doesn't make sense.

I agree with you, Charlie.

But at the same time, too, I believe Travis is worth it from his experience in working right along the side of him since or since he was hired and since I became superintendent.

I hear you I wouldn't be comfortable going up more than two steps and then I would want to have a discussion about what that means for the spring when everybody else gets another step in a cola does he still get another step on top

of that in the spring does the end of cola I mean I think everybody should get a I think there's two.

That would be my comfort level, I guess, is two steps and then a discussion about whether it gets another step in there in July.
